5. OTHER AGENDA ITEMS

5.1 <u>Cemetery Report</u>

The repairs to the Cemetery footpaths have been completed to a high standard. Councillors approved an additional payment of £1,700 as more tree roots than expected were encountered and the footpath repairs extend further than originally quoted.

5.2 Recreational Projects & Emmerdale Panel

The Chair reported that additional survey work requested by LCC Planning Officers has been completed and an account submitted for payment which will be refunded from Emmerdale monies.

The fitting of a new telephone box door, incorporating an anti-theft locking device, has been completed. Councillors expressed their thanks to Mr Bob Hill and Councillors Masterton and Suckall.

The Chair reported that the Emmerdale Panel has approved funding for the shower block at Wike Scout Camp. An application for funding submitted by Wigton Moor United Reformed Church has been withdrawn and will be re-submitted in January 2020.

5.3 Traffic and Parking Issues

The Clerk reported he had received complaints from local residents regarding GSAL students parking vehicles inconsiderately (and in one case, illegally) on High Ash Drive and High Ash Avenue. He visited the site to take photographs which have been forwarded to GSAL in an effort to resolve the issue.

Parking is also an issue in the vicinity of Wigton Moor School where many parents park inconsiderately, sometimes illegally and often with car engines idling. The Clerk will write to the school to request that parents give consideration to local residents and the environment.

LCC consultation on proposed parking restrictions in Harewood was discussed. Residents are encouraged to contact LCC with any comments on the proposals.

5.4 Christmas Lights

Councillor Hughes confirmed the lights in Wigton Moor will switched on the first Sunday in December. A possible date for the Harewood lights switch-on is <u>Friday 29 November</u>, Councillor Frankland will follow up and confirm.

5.5 Public Footpath Registration

Forms completed by local residents confirming they have used the public footpath into Harewood Church Graveyard have been received and will be forwarded to LCC as evidence for registering the path as a Public Right of Way.

5.6 HPC Newsletter

Councillor Frankland provided an update of items that can be included in the proposed PC Newsletter. Councillors will give consideration to the creation of a logo.

5.7 Uneven paving stones outside the High Ash Drive Co-op

The Clerk reported he has once again contacted the Co-op expressing disappointment that they have not responded to the complaint regarding uneven flagstones.

5.8 Public Footpath off The Avenue, Harewood

LCC has confirmed it does not own said strip of land, Councillor Frankland will make further enquiries with local residents to establish ownership.

5.9 **Spring Gardens Trees**

As a response has not been forthcoming from the LCC Officer contacted several weeks ago regarding this, the Clerk will refer this and other matters to LCC Chief Executive.

5.10 Remembrance Service 2019

There will be a short Remembrance Service in Harewood on the land opposite the Harewood Arms commencing 10.50am Sunday 10 November. All are welcome.
